

RESOLUTION CRA-R-2019-3

A RESOLUTION OF THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY (TOECRA) APPROVING THE EATONVILLE CHAMBER OF COMMERCE FUNDING APPLICATION FOR \$20,000 FOR THE SPECIFIC USE OF FUNDS FROM THE ECONOMIC REDEVELOPMENT GRANT IMPROVEMENT DESIGNATED FROM AND WITHIN THE 2018-2019 BUDGET CRA FROM LINE ITEM 78, ACCOUNT NUMBER 303-0515-515-6202 REDEVELOPMENT & GRANT PROGRAMS; PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, members of the governing body and two (2) additional members from the taxing authorities serve as Directors of the Agency; and

WHEREAS, such members constitute the head of a legal entity, separate, distinct, and independent from the governing board of the County and Municipality; and

WHEREAS, the Board of Directors are required to adopt an annual spending plan consistent with its CRA Plan and operations of the TOECRA; and

WHEREAS, the Board of Directors wishing to earmark funding for the Façade Grant Program to support façade improvements requested by the Eatonville Chamber of Commerce located at 213 West Kennedy Blvd.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY OF EATONVILLE, FLORIDA.

SECTION ONE: FINDINGS: the recitals set forth above are hereby acknowledged and accepted by the Eatonville Community Redevelopment Agency as findings made by the Board of Directors and does hereby incorporate such recitals as findings into this Resolution.

SECTION TWO: AFFIRMATION: The Board of Directors of the Eatonville Community Redevelopment Agency does hereby affirm its findings in the CRA Plan and Chapter 163, Florida Statutes as provided.

SECTION THREE: ALLOCATION OF FAÇADE GRANTS PROGRAM FUNDING:

The Board of Directors of the Eatonville Community Redevelopment Agency does hereby approve the application submitted by the Eatonville Chamber of Commerce and approve the funding request in the amount of \$20,000 for the specific use of the façade improvements as described in the approved application submitted by the Eatonville


Chamber of Commerce per the Project Funding schedule as attached to the application as submitted.
