

## RESOLUTION CRA-R-2022-19

A RESOLUTION OF THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY (TOECRA) BOARD OF DIRECTORS DIRECTING THE TOWN CLERK ~~CHIEF ADMINISTRATIVE OFFICER~~ OF THE TOWN OF EATONVILLE, PURSUANT TO THE INTERLOCAL AGREEMENT (CRA-R-2022-16) TO COMPILE AND RELEASE TO THE TOECRA ALL STUDIES, SURVEYS, GRANT DOCUMENTATION, AND RELATED DOCUMENTATION PREPARED BY, AT THE DIRECTION OF OR ON BEHALF OF THE TOECRA EXECUTIVE DIRECTOR FROM JANUARY 1, 2019 TO JULY 31, 2022, PROVIDING FOR CONFLICTS, SEVERABILITY, AND AN EFFECTIVE DATE.

### RECITALS

WHEREAS, by the enactment of an Orange County Ordinance #97-M-14 in 1997, the Town Council of the Town of Eatonville, Florida, created a community redevelopment trust fund for the community redevelopment area as provided by section 163.387, Florida Statutes;

WHEREAS the Town Council initially adopted a community redevelopment plan on October 25, 1997, pursuant to a resolution of Town Council (the "Plan"); and

WHEREAS the members of the governing body and one (1) additional member appointed by the respective taxing authorities serve as Directors of the Agency; and

WHEREAS such members of the governing body constitute the head of a legal entity, separate, distinct and independent from the governing board of the county and municipality; and

WHEREAS, the TOECRA desires to have a full audit of actions taken under the direction of the former Executive Director and non-compliant TOECRA BOARD in order to correct any acts or omission detrimental to the TOECRA.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN OF EATONVILLE COMMUNITY REDEVLOPMENT AGENCY OF EATONVILLE, FLORIDA:

**SECTION ONE: DIRECTION TO TOWN OF EATONVILLE TOWN CLERK ~~CHIEF ADMINSTRATIVE OFFICER.~~** The Board of Directors of the Town of Eatonville Community Redevelopment Agency does hereby, effective immediately, upon the passing of this Resolution direct the Town of Eatonville Town Clerk ~~Chief Administrative Officer~~, pursuant to the Interlocal Agreement between the TOECRA and Town of Eatonville, Florida, for compile and release to the TOECRA Board within sixty (60) days any and all studies, surveys, grant documentation, and related documentation prepared by, at the direction of or on behalf of the TOECRA Executive Director from January 1, 2019 to July 31, 2022.

**SECTION TWO: CONFLICTS.** All Resolutions of the Town of Eatonville Community Redevelopment Agency or parts thereof in conflict with the provisions of this Resolution are, to the extent of such conflict, superseded and repealed.

**SECTION FOUR: SEVERALBILITY.** If any section of portion of a section of this Resolution is found to be invalid, unlawful or unconstitutional it shall not be held to invalidate or impair the validity, force or effect of any other section or part of this Resolution.

**SECTION FIVE: EFFECTIVE DATE.** This Resolution shall become effective immediately upon its passage and adoption.
