

**RESOLUTION CRA-R-2022-23**

A RESOLUTION OF THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY (TOECRA) BOARD OF DIRECTORS DIRECTING THE EXECUTIVE DIRECTOR OR APPOINTED STAFF TO PROVIDE TOECRA BOARD MEMBERS WITH THE TOECRA AGENDA AND PACKET MATERIALS FOR EACH AND EVERY TOECRA REGULAR MEETING ONE (1) WEEK PRIOR TO THE SCHEDULED MEETING.

**RECITALS**

WHEREAS, by the enactment of an Orange County Ordinance #97-M-14 in 1997, the Town Council of the Town of Eatonville, Florida, created a community redevelopment trust fund for the community redevelopment area as provided by section 163.387, Florida Statutes; and

WHEREAS the Town Council initially adopted a community redevelopment plan on October 25, 1997, pursuant to a resolution of Town Council (the "Plan"); and

WHEREAS the members of the governing body and one (1) additional member appointed by the respective taxing authorities serve as Directors of the Agency; and

WHEREAS such members of the governing body constitute the head of a legal entity, separate, distinct, and independent from the governing board of the county and municipality; and

WHEREAS, the TOECRA desires to have adequate time to properly prepare for TOECRA business by having the agenda and packet materials delivered the each TOECRA Board Member in such a time period to allow for the same.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN OF EATONVILLE COMMUNITY REDEVELOPMENT AGENCY OF EATONVILLE, FLORIDA:


**SECTION ONE: DIRECTION TO TOWN OF EATONVILLE EXECUTIVE DIRECTOR OR APPOINTED STAFF ~~CHIEF ADMINISTRATIVE OFFICER~~.** The Board of Directors of the Town of Eatonville Community Redevelopment Agency does hereby, effective immediately, upon the passing of this Resolution direct the Executive Director or appointed staff to provide TOECRA Board Members with the TOECRA Agenda and packet materials for each and every Regular Meeting, one (1) week prior to the scheduled meeting to commence with the December 2022 Regular TOECRA Meeting.

**SECTION TWO: CONFLICTS.** All Resolutions of the Town of Eatonville Community Redevelopment Agency or parts thereof in conflict with the provisions of this Resolution are, to the extent of such conflict, superseded and repealed.

**SECTION FOUR: SEVERABILITY SEVERALBILITY.** If any section of portion of a section of this Resolution is found to be invalid, unlawful, or unconstitutional it shall not be held to invalidate or impair the validity, force or effect of any other section or part of this Resolution.

**SECTION FIVE: EFFECTIVE DATE.** This Resolution shall become effective immediately upon its passage and adoption.
